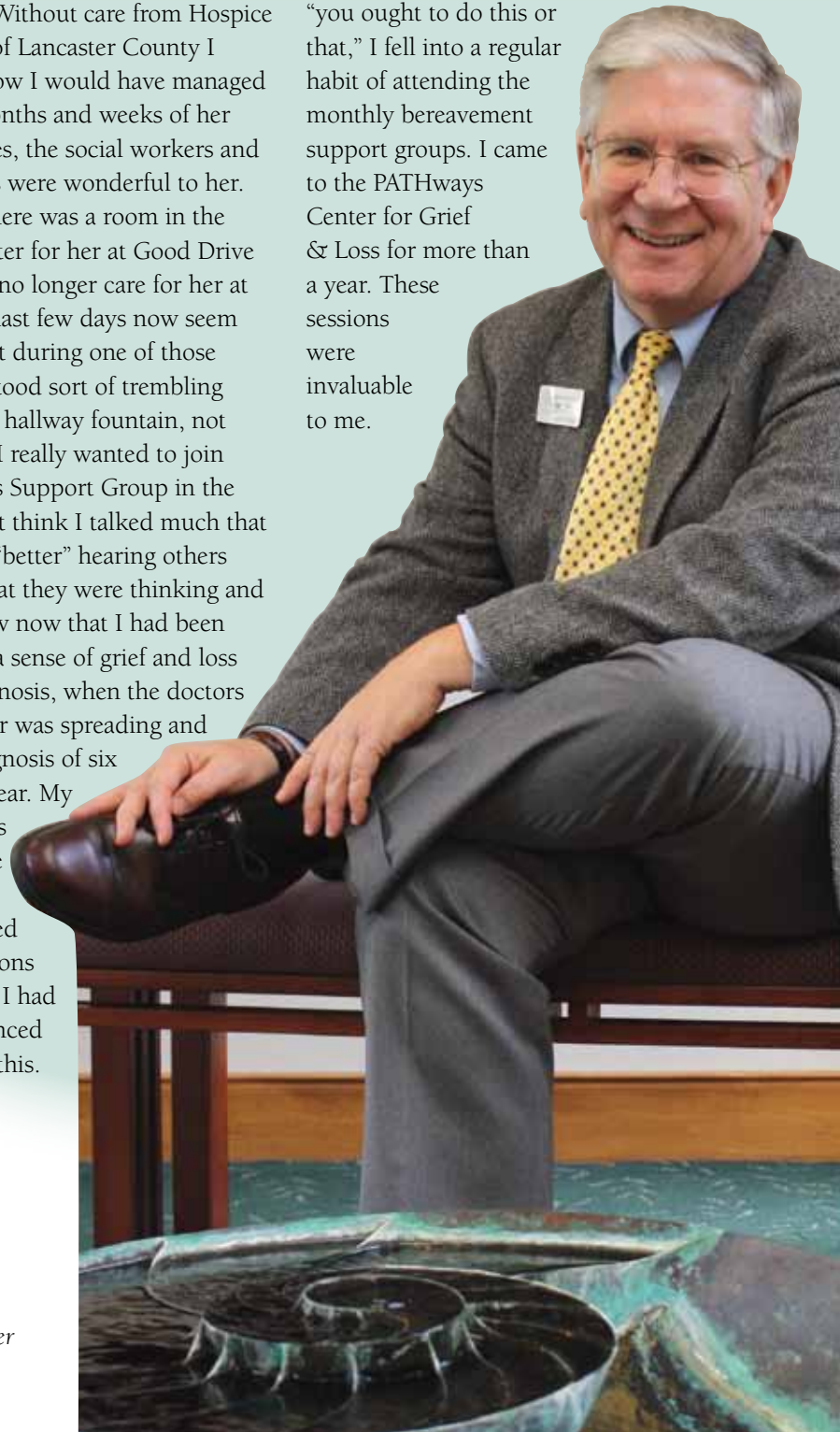

Completing the Circle of Giving:

Supporting Others After Receiving Support

My wife Marilyn died in 2001 of brain cancer. Without care from Hospice of Lancaster County I don't know how I would have managed those final months and weeks of her life. The nurses, the social workers and the volunteers were wonderful to her. Fortunately there was a room in the Inpatient Center for her at Good Drive when I could no longer care for her at home. Those last few days now seem like a blur, but during one of those afternoons I stood sort of trembling in front of the hallway fountain, not sure whether I really wanted to join the Caregiver's Support Group in the Library. I don't think I talked much that day but I felt "better" hearing others talk about what they were thinking and feeling. I know now that I had been experiencing a sense of grief and loss since her diagnosis, when the doctors said the cancer was spreading and gave us a prognosis of six months to a year. My ability to focus or concentrate was poor. My mind wandered and my emotions surprised me. I had never experienced anything like this. I felt STUCK.

After the funeral, the cards, the casseroles and people's well-intended "you ought to do this or that," I fell into a regular habit of attending the monthly bereavement support groups. I came to the PATHways Center for Grief & Loss for more than a year. These sessions were invaluable to me.

The staff and volunteers provided an opportunity for me, and others, to tell our stories. It was comforting to know others were experiencing similar feelings, questions, emotions and thoughts. I quickly found that I wasn't "crazy" and my experiences were not unique. Often there would be several of us nodding our heads as people's stories would be told. We could identify with what was being said. People in the group "got it." It was a safe and comfortable place to share what was in our hearts and minds. I recall driving home after one such evening reflecting how helpful the group discussion had been and

thinking to myself about the role of the volunteer in leading support groups. They were individuals who had the same loss as I did and whose words of encouragement and insight to the grief journey came from experience.

The next month before the session started I asked one of those volunteers about her role and training to help facilitate groups. I knew then that

one of the ways I wanted to honor Marilyn's memory was to become one of those volunteers. I have gained insight, made several lasting friendships with other volunteers and am honored to journey with others in their grief and loss. Hospice of Lancaster County is a tremendous resource and I'm pleased to be part of fulfilling its mission in the community. ■

Give a Gift that eases the Burden on Your Loved Ones.

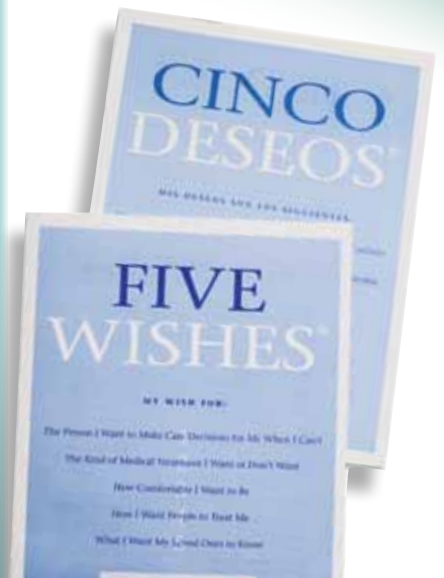
Hospice of Lancaster County with other national, state and community organizations, is participating again this year in a massive effort to highlight the importance of advance healthcare decision-making. That effort culminates on April 16, 2011, National Healthcare Decisions Day.

According to Joan Harrold, MD, MPH, FAAHPM, Medical Director and Vice President of Medical Services at Hospice of Lancaster County, communication is critical. "Advance healthcare directives are an important part of getting the kind of care you want if you are seriously ill," she says. "Write it down, then talk to your doctor, your family and your close friends about what is really important to you. Help them by making your intentions clear about the decisions that you want to be made if you can't make them yourself."

Advance directives allow you to document your end-of-life wishes in the event that you are terminally ill or critically injured and unable to talk or communicate. *Five Wishes* is a document that helps you express how you want to be treated if you are seriously ill and unable to speak for yourself. *Five Wishes* addresses medical, personal, spiritual and emotional needs.

Partnership that Keeps on Giving:

KEHPCA and Hospice of Lancaster County

In support of a partnership that began in February 2009, four representatives of Hospice of Lancaster County visited the Kenya Hospice and Palliative Care Association in Nairobi, Kenya. Jo Sensenig, Theresa Robertson, Gwen Hostetter and Dr. Joan Harrold learned about the challenges in providing hospice and palliative care in a developing country with fewer resources.

While there, they participated in the World Hospice Day

celebration, joining Kenyan hospice staff walking in a parade through Nairobi to raise awareness of hospice and palliative care. They also delivered gifts including art supplies for children, medical supplies and contributions made through fundraisers.

There are dramatic differences in needs and resources compared to those in the U.S. In Lancaster County, staff might have occasional transportation challenges, often related to weather. In Kenya, lack of a vehicle capable of navigating the terrain made it difficult for our team to get to a patient's home to make a visit. One of KEHPCA's

goals is to purchase a vehicle capable of reaching the 28 small hospices that depend on KEHPCA for education, training, medications and support.

Another difference is in the need for equipment and supplies. In the U.S., hospices have easy access to electronic medical records, medication pumps and diagnostic tests. After spending an entire day trying to visit one patient in remote Laikipia, our staff asked hospice nurse Joyce Marete if she had any specific needs. Her sole request was for a stethoscope.

Dr. Harrold believes that their trip made a difference: “We were able to provide clinical education to assist our colleagues in Kenya and affirm that what they do is important, valuable and worthwhile.”

Hospice of Lancaster County staff members have raised funds for KEHPCA through sales of gift cards and Kenyan crafts and through voluntary payroll deductions. Ten Thousand Villages stores have generously donated a percentage of sales on designated shopping nights. Funds donated to Hospice of Lancaster County are used to support patients and families locally. Only donations given specifically to the Kenyan partnership are sent to Kenya. Staff visiting Kenya paid for their travel and lodging. ■



Hearts Unite: Women's Giving Circle

Since 2004, Hospice of Lancaster County's Women's Giving Circle has doubled in size from the original 24 members and has raised \$140,500 for projects that build and strengthen Hospice-related programs. At their annual meeting on

November 11, members of the Women's Giving Circle voted to fund \$25,000 for 11 projects in 2011 that include furnishings and equipment for pediatric patients served in the Inpatient Centers, gift cards for groceries and medications for patients and families in need and advanced training for one of Hospice's massage therapists.

"This past year the proposals brought forward were very diverse, allowing us the opportunity to help patients, caregivers and hospice staff in many ways," said member Carol Hartley.

Each member has a say in what projects are funded—the group particularly likes to find outlets that support hospice that may not be in the organization's standard funding.

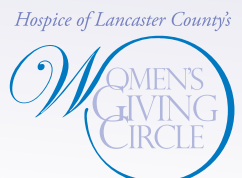

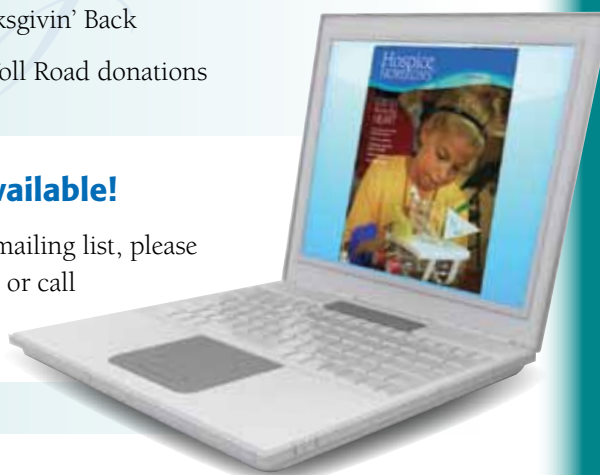
